Subject : Dropping of roads approved in Phase-II (2001-03) of PMGSY in Uttaranchal-  
Regarding.

Madam,

I am directed to refer your letters No.200/I 2-01/PMGSY/Deharadun dated 16.2.2004 and No.2089/GVV/PMGSY/Deharadun dated 2.12.2004 on the subject mentioned above and to say that the matter has been examined by this Ministry and the request of the State Government for dropping of the following 2 roads works earlier approved at a cost of Rs.242.73 lakh has been agreed to :

- (i) Tanakpur - Tawaghat road to Rathi, (length 8.00 kms.) District Pithoragarh. - 126.00  
(ii) Lipulekh - Bhind Motor Road to Fagpur, (length 1.7 kms.) District Champawat. 37.72

The Birmolikhal Suradi road works proposed in substitution is under examination by NRRDA.

2. As regards dropping of the Mansuna Gadagu Motor Marg in Rudraprayag district, it may please be intimated whether the habitation connected with 3.5 kms. of road length, is in the Core Network. In case, the habitation is not covered by the Core Network, it cannot form part of PMGSY and either the road work has to be completed as per the original proposal or the State Government may bear the entire cost of construction of this road.

3. It is also requested that the OMMS data may please be modified accordingly.
